Notice is hereby given pursuant to V.T.C.A. Government Code, Chapter 551 that the Board of Directors of Trail of the Lakes Municipal Utility District will meet in regular session, open to the public, at 12:00 p.m. on Monday, March 23, 2026, at 9 Greenway Plaza, Suite 1000, Houston, Texas 77046, a designated location outside the Boundaries of the District. 1. Consideration of Public Comments.*
2. Consideration of comments from the Property Owners Association/Homeowners Association representatives.*
3. Enter into Executive Session.
4. Approve minutes from the meeting of February 23, 2026.
5. Hear Security Report and consider taking action thereon.
6. Hear Tax Assessor/Collector's Report, and consider taking action thereon, including:
 - a. authorize payment of bills from the tax account; and
 - b. review Delinquent Tax Attorney's Report.
7. Adopt Resolution Concerning Tax Exemptions for 2026.
8. Adopt Resolution Implementing 20% Penalty on Delinquent 2025 Taxes.
9. Hear Financial Advisor's Report and consider taking any action thereon, including:
 - a. approve Order Adopting Official Notice of Sale and Preliminary Official Statement for the Series 2026 Unlimited Tax Park Bonds (the "Bonds");
 - b. authorize advertisement for the sale of the Bonds; and
 - c. authorize Consultants to proceed in preparing documents and to take any necessary actions related to the Bonds.
10. Hear District Communications Report and consider taking action thereon.
11. Hear Solid Waste and Recycling Report and consider taking action thereon; including:
 - a. schedule tour of recycling plant; and
 - b. schedule date for E-recycle and shred event.
12. Hear Bookkeeper's Report, and consider taking action thereon, including:
 - a. review investments; and
 - b. approve payment of bills and issuance of checks.
13. Hear Operator's Report, and consider taking action thereon, including:
 - a. authorization of termination of water and sewer service to delinquent accounts;
 - b. discuss status of aeration tank repairs and consider taking necessary action;
 - c. authorize Operator to make necessary repairs to water and sanitary sewer system; and
 - d. status of miscellaneous operational and customer matters.
14. Hear Engineer's Report, and consider taking action thereon, including:
 - a. review and approve pay estimates and change orders to construction contracts, as needed;
 - b. review new service requests/applications;
 - c. review Water Well No. 4 assessment and rehabilitation;
 - d. status of repair to Williams Gully Channel P130-02-00;
 - e. status of Rankin Road right-of-way modifications; and
 - f. status of preparation of Bond Application Report ("BAR") No. 17.
15. Hear Double Oak Maintenance Report and consider taking action thereon.
16. Review bids for detention pond landscaping contract and take action thereon.
17. Hear Transcend Groundworks Report and consider taking action thereon.
18. Hear District Recreational Facilities Management Report and update on development of recreational facilities, and consider taking action thereon, including:
 - a. status of improvement, repair, and maintenance projects;

- b. capital park projects design and preliminary work; and
 - c. discuss 2026 National Night Out.
19. Hear Attorney's Report and consider taking action thereon, including:
- a. discuss and consider adopting new meeting locations.
